

NO PURCHASE OR DONATIONS ARE NECESSARY TO ENTER OR WIN. The WLJT Writers and Illustrators Contest is produced by WLJT. The contest begins on Jan. 1, 2017 and ends with the announcement of winners on or about May 19, 2017. This contest consists of a local judging only. To enter the Contest you must submit your entry to WLJT. They must be delivered to the station or postmarked by March 31, 2017 to be eligible for competition. Eligibility & Entry Guidelines

- Entrants must be children 4th or 5th grade.
 - Children of employees of PBS and Discovery Park of America, PBS stations or their affiliates, sales representatives, subsidiaries or parent companies, advertising/sales promotion agencies, and judges are not eligible.
 - Only one entry per person will be accepted in this contest; all subsequent entries will be disqualified.
 - Only single author stories qualify (no co-authored stories).
 - Stories can be fact or fiction, and prose or poetry.
 - Any failure to adhere to these contest rules may result in disqualification from the contest.
- No purchase or contributions are necessary.

Word Count Requirement

Fourth and Fifth grade stories must have a minimum of 100 words and a maximum of 500 words. The word count includes “a,” “an,” and “the,” but not the words on non-story pages such as the title page or those that enhance the illustrations.

Text must be printed or written legibly or typed.

Children who cannot write may dictate their story to be printed, written legibly or typed.

Text may be integrated into the illustration pages or on separate pages.

Non-English text must be translated on the same page and the translated text (English text) must adhere to word count.

Invented spelling is accepted.

Format & Illustrations

Stories must have at least 5 original, clear and colorful illustrations.

Original art can include drawings, collages, and 3-D images created by the author or photographs taken by the author.

Stories submitted must be created on one side of the paper and numbered on the back of each page.

Official Entry Form

Each entry must include the official WLJT Contest Entry Form, with the required signature of a parent/guardian (and, if appropriate, the optional signature of the sponsoring teacher), consenting to allowing their child/ward to enter the contest, confirming that the story and art are original, and granting certain rights to the entry materials.

The entry form must be complete and legible to be eligible.

Judging, Awards & Notification

All entries submitted will be judged by a panel of judges from WLJT and Discovery Park of America. Judging dates will be set by WLJT and should take place about mid-April :

Criteria:

40% Creativity and originality of plot and/or themes,

40% Story structure and use of literary devices,

20% Relevance, quality and originality of illustration

All decisions of the judges are final and binding and not subject to appeal or review. Winners will be notified no later than April 28, 2017.

Prizes

There will be one first place winner from fourth grade and one from fifth grade and a second place winner from each of the grades. They will receive a one-year membership to the Discovery Park of America. If the winners already have a membership, they will receive a gift card.

The winners' schools will be awarded prizes from Discovery Park's scholarship fund. The schools of the first place winners will be awarded \$100 each and the runner-up winners' schools will be awarded \$50 each. The scholarship money will be used to help pay for a field trip to Discovery Park of America in Union City, TN. The school will be responsible for the specific details of the field trip. Winners will also receive other prizes including arts and crafts supplies and books provided by WLJT.
